# Toongabbie Structure Plan

PLANNING SCHEME AMENDMENT C126




The Toongabbie Structure Plan seeks to guide land use and development in the town based on land use constraints, opportunities and the desires of the community. The Toongabbie Structure Plan builds on work undertaken through the Amendment C105 Live Work Latrobe Housing Strategy 2019, the Rural Land Use Strategy 2019 and community engagement and workshops held in 2019.

Amendment C126 implements the findings of the Toongabbie Structure Plan report and background reports and the recommendations from the West Gippsland Catchment Management Authority 2016 Flood Study for Toongabbie into the Latrobe Planning Scheme.

A new Neighbourhood Residential Zone, Schedule 5 for Toongabbie is proposed, as are rezonings and the application of additional flooding overlays consistent with the Toongabbie Structure Plan. Rural Living and other rezonings are being undertaken as part of Amendment C127.

Delays have been experienced in the exhibition of these amendments due to delayed feedback from the CFA. Furthermore, the postponed finalisation of Amendment C122 (Planning Policy Framework) has resulted in deferred timeframes for exhibition of these amendments.



# Aim

- Guide appropriate changes to land use, development and built form to ensure the sustainable future growth of Toongabbie.
- Identify land use constraints that will impact on the growth and development of the locality.

## What Has Occured So Far?

#### Stage 1 2019/2020

Consultation with landowners/stakeholders.

Background reports completed including Toongabbie Structure Plan July 2020.

#### Delays

Delays were experienced between the completion of Council's work and the exhibition period due to ongoing delays in the receipt of feedback from the CFA and the drawn-out finalisation of Amendment C122 Planning Policy Framework by DELWP.

#### Current

Development of Planning Scheme Amendment documentation and exhibition.
