## **What it is:**

30 – 50 minute timeslots on stage, in the undercover space at GPAC on Kay Street, Traralgon.

**Date:** Traralgon Farmer's Market Saturdays, the fourth Saturday of each month

**Time:** 9am – 12pm

## **What is included:**

**Technical:** 240V and 3phase power, 4x4m modular stage, mics and speakers, basic lighting, casual outdoor seating with tables, umbrellas and beanbags. A secure place to store your instruments.

**Promotional:** The use of an A-frame to display signage / posters that promote your music/ group etc.

## **Please note:**

GPAC is unable to supply any additional musical or technical equipment. Please bring along your own tested and tagged equipment, tuned and ready to go.

GPAC will promote the general Music Undercover events but not individual bands/ musicians.
