# **About the Traralgon Recreation Reserve and Showgrounds**

- The Traralgon Recreation Reserve and Showgrounds comprises Crown Land managed by Latrobe City, Council owned land and land and buildings owned by the Traralgon and District Agricultural Society, Traralgon Football Netball Club, Traralgon Urban Fire Brigade and the Traralgon East Development Association of Sport (TEDAS Junior Football Club).
- The reserve has a large and diverse range of stakeholders and sporting, recreation and agricultural activities.
- There are two sporting and event ovals, fire running and marshall tracks, sporting changerooms, public toilets, open space areas, club pavilions, agricultural show pavilions, netball court and sporting social club.

### **About the Positions**

- Latrobe City Council is seeking Expressions of Interest to fill 2 community representative positions.
- All members are appointed for a term of 3 years and are expected to commit to that term.
- Have a strong interest in providing advice and direction to Latrobe City in the management, maintenance, development and use of the Traralgon Recreation Reserve and Showgrounds.
- Interested persons are to be over the age of 18 years, be a resident of Latrobe City or own property and/or work in the municipality.
- The Advisory Committee meets bi-monthly at Gippsland Regional Indoor Sports Stadium, Traralgon. The duration of each meeting will generally not exceed one and a half hours. Special meetings may be held on an 'as required' basis.
- Appointments to the Advisory Committee are made by Latrobe City Council.
- All positions are on a voluntary basis and Latrobe City does not offer any remuneration for participation.
- All positions can refer to Latrobe City's Coordinator Recreation Liaison and Reserves Maintenance for assistance and advice throughout their term of appointment.

### **About the Traralgon Recreation Reserve and Showgrounds Advisory Committee**

- The Committee's role is to provide advice and direction to Latrobe City in the management, maintenance, development and use of the Traralgon Recreation Reserve and Showgrounds under a Terms of Reference operating document.
- The Advisory Committee has no delegated decision making authority.


