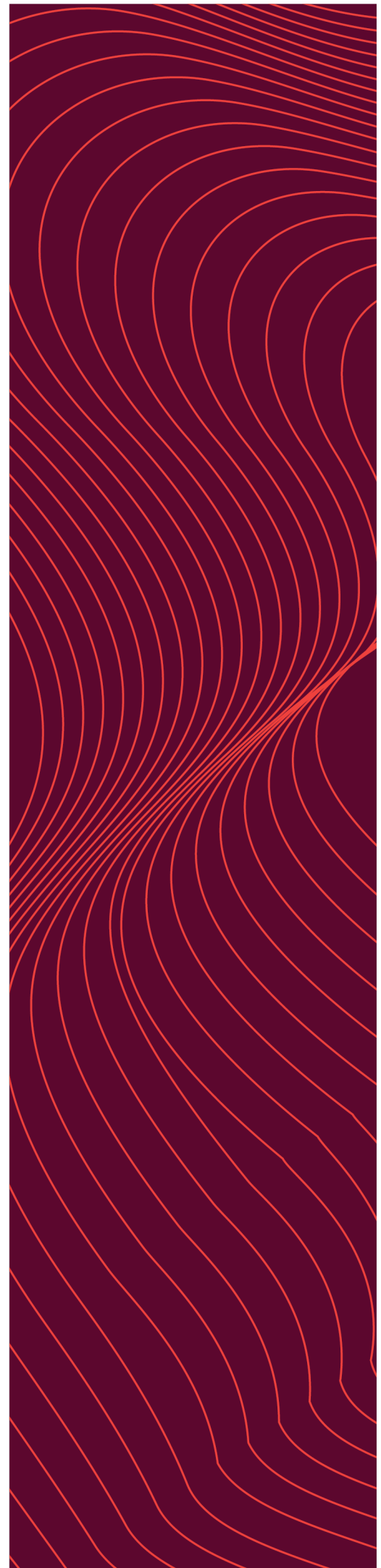

# Latrobe Regional Airport – Aircraft Usage Charges & Exemptions

## General Charging Principles

- All aircraft landings and parking are logged and billed through Avdata Australia.
- All fees listed include GST and are reviewed every financial year.
- If an aircraft or flight is marked as EXEMPT, no charge will apply.

## Landing & Take-Off Charge Summary

### Exemptions – No Fee Applies

The following categories are exempt from landing and take-off charges:

- Gliders
- Balloons
- YLTV Airport Usage Types:
  - TO – Take-Off
  - MA – Missed Approach
  - IL – ILS Practice Approach
  - VO – VOR Practice Approach
  - ND – NDB Practice Approach
  - GP – GPS Practice Approach
  - RN – RNAV Practice Approach
  - PA – Practice Approach
- Aircraft in group: 'Latrobe Airport (YLTV) Exempt Aircraft'
  - Latrobe Airport Aircraft Exemption application form to be submitted via Airport Manager to AvData.
- Aircraft in group: 'Latrobe Airport (YLTV) Maintenance'
  - Latrobe Airport Maintenance Exemption application form to be submitted via Latrobe Regional Airport Manager to AvData.

### Standard Landing Charges

All other aircraft that do not meet the above exemptions will be charged:

- Landing / Stop & Go / Touch & Go  
\$13.50 per tonne (minimum charge applies)

Landing Charges are Limited To:

- 1 charge per 20 minutes

## Parking Charges Summary

### Exemptions – No Parking Fees

The following categories are exempt from parking charges:

Aircraft used for maintenance

- Aircraft in group: 'Latrobe Airport (YLTV) Maintenance'
  - Latrobe Airport Maintenance Exemption application form to be submitted via Latrobe Regional Airport Manager to AvData

### Standard Parking Charges

All other aircraft that do not meet the above exemptions will be charged:

- Grass Parking \$3.00 per tonne (minimum charge applies)
- Hardstand Parking \$6.00 per tonne (minimum charge applies)

Parking Charges are Limited To:

- 1 charge per 20 minutes
- Maximum 1 charge per day
