

INDUSTRY GROWTH PROGRAM

25eight recognises that there isn't a one size fits all approach to business and that most formal business education uses larger enterprise as case studies. PROGRAM OVERVIEW

In the 12-week Latrobe City Council Industry Growth Program there is a combination of inperson, online, peer-to-peer and one-to-one support.

The outcome for every business is a bespoke strategy and growth action plan tailored specifically to your business situation and goals.

The program kicks off with an in-person event held in Latrobe City on 2 February, 2026. You'll then get access to 25eight Academy, our online learning platform, where you'll complete an individual diagnostic. You will then self-pace through online business education following a weekly schedule. This is complemented by live online group scheduled sessions in weeks 3, 6 and 9 and one-to-one coaching sessions that you book into, when prompted. You'll also have access to an online community and facilitated peer-to-peer mentoring sessions.

In the final in-person session in Latrobe City 28 April, 2026, you'll have the chance to present your business to the group before pitching your business to an Industry Mentor for immediate feedback.

WHO THIS IS FOR

Business owners and leaders of medium sized businesses

- Utilise technology, including AI, to accelerate your progress.



This program teaches you how to use simple frameworks to help make strategic decisions quickly so that if circumstances change, you can use what you have learned again, increasing your strategic agility to deal with future market changes.

By also connecting with Industry Mentors you'll get immediate feedback, insights and guidance from those within or with experience in your target market.

ELIGIBILITY

Eligibility

- Each business must have a valid ABN.
- Businesses must be registered and/or operate from a physical location within the municipality
- The Latrobe City Council Industry Growth Program is open to businesses that have been in operation for more than 5 years i.e. commenced operating before 28 November, 20210
- Businesses in operation less than 5 years will need to articulate strongly for inclusion and may be included at the discretion of the application reviewers.
- The business owner or major decision maker is the primary applicant. (Noting up to three participants per business can participate).

Businesses not eligible:

- In breach of any Federal, State/Territory or local government law or regulation.
- Have any outstanding debts owing to Latrobe City Council.
- Owned by a current employee or Councillor of Latrobe City Council.
- Have any open or outstanding compliance matters with Latrobe City Council.
- The primary operation relates to the sale of tobacco and tobacco related products i.e. e-cigarettes, shisha, hookahs and pipes, gambling and electronic gaming machines or any illegal activities.
- Entities that denigrate, exclude, or offend parts of the community.
- Political organisations or organisations that have a political purpose.



SELECTION PROCESS


Selection will follow these steps:

- Businesses wishing to be considered for the Industry
 Growth Program must complete the application in full and submit prior to the closing date of 28 November, 2025.
- Applicants who meet the selection criteria will be short listed.
- A review panel will assess all applicants and use a threelevel scoring matrix.
- All businesses will be notified of the outcome by **December**,
 2025.
- Latrobe City Council reserves the right not to issue all places in the Latrobe City Council Industry Growth Program if an appropriate application is not available.


Applicants will be scored against the following three criteria:

- Commitment to the completion of the program and in-person and online session dates.
- Enthusiasm and passion for growing their business.
 demonstrated by the description of benefits to the business in the application.
- The growth potential of their business.

- Complete all contact details on the application form.
- Application and participation in the Latrobe City Council Industry Growth Program is free of charge.
- Once you submit your application, it cannot be edited. To make changes to a submitted application an entirely new application will need to be submitted.
- Applications must be prepared and submitted by the business.
- Applications made by third parties on behalf of businesses will not be accepted.
- Incomplete applications will not be accepted.
- To be eligible for the Latrobe City Council Industry Growth Program 2026 businesses must have been in operation for at least 5 years i.e. commenced operating before August, 2020.
- Businesses in operation less than 5
 year will need to articulate strongly
 for Latrobe City Council Industry
 Growth Program inclusion, and may
 be included at the discretion of the
 application reviewers.
- Where a business operates from multiple locations, the application must reflect the initiatives related to the municipality of Latrobe
- Applications will be reviewed and entrants awarded by a selection panel.
- Businesses may be contacted to discuss their application prior to a decision made.

- The panel's decision is final.
- By nominating you agree to have your business name, and any photos or videos produced in relation to the Industry Growth Program used by Latrobe City Council for promotional activity.
- This may include but is not limited to print publications, website and social media channels.
- Participation in the program and access to 25eight Academy is also governed by the <u>terms and</u> <u>conditions</u> of 25eight.
- Latrobe City Council will not be liable for any action or claim arising from or in connection with this application and its assessment and/or participation in the program.
- Awarded businesses must commit to having the same senior business representative at each of the two in-person x 2.5-hour, workshops held in Week 1 and 12 and the three virtual sessions held in Weeks 3, 5, and 9.
- Businesses must commit to completing the 12-week program in full as this is considered a significant investment in your business over other non-selected businesses.
