Notice of the preparation of an amendment to a planning scheme

Amendment C151latr

Overview

The Amendment proposes to implement the recommendations of the Latrobe City Signage Strategy 2025 by introducing new local content to the Planning Policy Framework, amending the schedules to Activity Centre Zones, and introducing the Latrobe City Signage Strategy 2025 as a background document.

Details of the amendment

The Latrobe City Council planning authority has prepared Amendment C151latr to the Latrobe Planning Scheme.

The land affected by the amendment is throughout the whole municipality of Latrobe City Council.

The amendment proposes to implement the recommendations of the Latrobe City Council Signage Strategy 2025 into the Latrobe Planning Scheme (the Strategy). The Strategy aims to streamline the planning permit application process by providing clarity and details about the types of signage that will be supported in the Latrobe Planning Scheme.

The amendment makes changes to the Planning Policy Framework and Activity Centre Zones introducing new and amended policy for the development of land for signage.

Any person may make a submission to the planning authority about the amendment. Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds on which the amendment is supported or opposed and indicating what changes (if any) the submitter wishes to make.

Name and contact details of submitters are required for the planning authority to consider submissions and to notify such persons of the opportunity to attend planning authority meetings and any public

hearing held to consider submissions.
