Important information for applicants

Please note:

- A \$292.50 application fee applies and must be paid when submitting this application or renewal.
- An extra fee is payable annually at audit of \$31.00 per adult animal audited (breeding/rearing only).
- The registration of this Domestic Animal Business is renewable every year on or before 9 April and is not transferrable unless Council is notified in writing at least 30 days prior to the transfer.
- The operation of any such establishment or the keeping of animals is prohibited unless Latrobe City Council has given formal written approval.
- Local Laws staff will make contact to arrange a suitable time for your property to be audited in accordance with the applicable Code of Practice.
