OUTGOING MAYOR SPEECH

TERM OF OFFICE AND ELECTION OF THE MAYOR

MOTION

Moved: Cr Gibson Seconded: Cr Morgan

That Council:

- a) determines that the term for the Office of Mayor will be one year;
- b) proceeds to elect the Mayor in accordance with the Governance Rules for one year, to serve for the 2025/2026 Mayoral term; and
- c) determines that candidates may speak to their nomination.

CARRIED UNANIMOUSLY

Nominations for the Office of Mayor:

Cr Harriman nominated Cr Gibson for the office of Mayor. Cr Gibson accepted. Seconded Cr Pugsley.

Cr Potter nominated Cr Morgan for the office of Mayor. Cr Morgan accepted. Seconded Cr Howe.

Cr Gibson and Cr Morgan did not speak to their nominations.

In favour of Cr Gibson

For Crs Pugsley, Gibson, Barnes, Campbell and Harriman.

In favour of Cr Morgan

For Crs Potter, Morgan, Lund and Howe.

Cr Gibson, having received the absolute majority of votes in favour, was elected as Mayor.

TERM OF OFFICE AND ELECTION OF THE DEPUTY MAYOR

Outgoing Deputy Mayor, Councillor Gibson, reflected on her term as Deputy Mayor.

MOTION

Moved: Cr Pugsley
Seconded: Cr Morgan

That Council:

- a) establishes an office of Deputy Mayor for a one-year term;
- b) proceeds to elect the Deputy Mayor in accordance with the Governance Rules for one year to serve for the 2025/2026 Deputy Mayoral term; and
- c) determines that candidates may speak to their nomination.

CARRIED UNANIMOUSLY

Nominations for the Office of Deputy Mayor:

Cr Pugsley nominated Cr Harriman for the office of Deputy Mayor. Cr Harriman accepted.

Seconded Cr Campbell.

Cr Potter nominated Cr Morgan for the office of Deputy Mayor. Cr Morgan accepted. Seconded Cr Howe.

Cr Morgan nominated Cr Campbell for the office of Deputy Mayor. Cr Campbell did not accept.

Cr Harriman and Cr Morgan spoke to their nominations.

In favour of Cr Harriman

For Crs Pugsley, Barnes, Campbell, Harriman and Gibson.

In favour of Cr Morgan

For Crs Potter, Morgan, Lund and Howe.

Cr Harriman, having received an absolute majority of votes in favour, was elected as Deputy Mayor.
